## Previous Annual General Meeting Minutes

### The British Computer Society – London (Central) Branch

11<sup>th</sup> October 2018 at 6.00pm

It was noted that a quorum was present as there were 37 members attending.

#### 2. Minutes of the AGM held on 19<sup>th</sup> October 2017

The minutes were approved.

#### 3. Chair's Report

Mr Jewell presented the Chair's report. He highlighted the great programme which featured lots of talks, debates and workshops. He commented on the high level of engagement and quality of the questions asked. The events facilitated networking, with members acting as a community, and the quality of the food was noted.

He noted the mission of "making IT good for society" and thanked speakers for their effort and tremendous contribution.

Mr Jewell mentioned the career and CV advice webinars that the branch offered, as well as securing discounts to external events.

It was noted that participation in events was in line with previous years, but a small number of particularly successful events resulted in the average increasing.


## Honorary Treasurer’s Report Financial Year 2018/19

I am pleased to present the Honorary Treasurer’s Report for the London Central Branch for the financial year 2018-19, this being September 2018 through August 2019. This report is presented at the Branch’s Annual General Meeting on Thursday 10<sup>th</sup> October 2019 and it contains information correct as at Thursday 3<sup>rd</sup> October 2019.


### Financial Year 2018/19

To fund our operations during this period, we submitted a budget request of £7,801, which included £2,222 for eleven student prizes. In August 2018, we were told that our operational funding would be £6,800 including £2,222 for eleven student prizes.

During this financial year, the branch spent £5,552, comprising £4,304 running costs and £1,208 for student prizes, which was £1,248 or about 18% below our allocation of £6,800.

The primary reasons for this underspend were that we only had one speaker expense claim, and that we have outstanding student prizes still to purchase.

### Financial Year 2018/19

For the forthcoming financial year 2019-20, being September 2019 through August 2020, the branch submitted a budget request in March 2018 of £7,725 for operational funding to include



£2,222 for eleven Student Prizes. No requests were made for special events, so the total requested was £7,725.

In August 2018, we were told that our operational funding would be £6,952 including £2,222 for eleven student prizes.
